Charitable gift annuity regulations vary from state to state and St. Michael's Media may not be able to offer a gift annuity in a particular state. 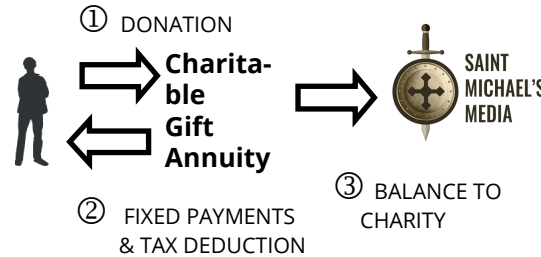
WHAT IS A CHARITABLE GIFT ANNUITY?
